

# Welcome to Travel Visa Experts

In this attachment is published a list of the countries we offer Visa Service for and other supporting documentation required for entering a foreign Country.

**Important Note:** The processing time for E-visas can vary depending on a number of factors, including the time of year, the volume of applications being processed, and the complexity of your application. It is recommended that you **apply 4 weeks prior departure**.

Information provided below is based on Irish and UK Passport Holders.

Travel Visa Experts will require a minimum of 7 working days before your departure to submit the application on behalf of yourself. If the departure time will be less than 7 days, unfortunately the time frame will be too short.

As the entry requirements are subject of a daily change we recommend you to Contact us before to submit your application.

Please note, the Health and Customs Declaration forms, Traveller Declaration Forms, E-arrival Cards, etc. are very important to be completed before departure for some of the countries, otherwise may result in Denied Boarding.

Having all the documents prepared before your trip assures you a smooth Immigration process when you land.

For some specific destinations obtaining a Visa on Arrival can take up to 2h 30 min.

## Documents required to enter to the following countries.

### Australia



Passport valid for at least 6 months on your arrival back in home country.

Electronic Travel Authorisation (subclass 651) – valid for 1 year for a stay of max.3 months **or**

Electronic Travel Authorisation (subclass 600) - valid for 1 year for a stay of max. 6 months.

### Cambodia



Passport valid for at least 6 months on your arrival back in home country.

E-Visa (T- type) – Electronic Visa before departure or Visa on Arrival **and**

E-Arrival Card completed 7 days prior departure.

*Note: E-visa is not eligible through all the ports of Entry in Cambodia.*

### Canada



Passport valid for at least 6 months on your arrival back in home country.

Electronic Travel Authorisation – ETA- is valid for five years from the date of issue or until your passport expires, whichever comes first.

## India



Passport valid for at least 6 months on your arrival back in home country.

E-visa 30 days single entry **or**

E-visa 1year multiple entry. (Valid for 1 year from the date of issue for stays up to 3, 6 or 9 months, the decision is always at the discretion of Immigration Officer).

*Note: E-visa is not eligible through all the ports of Entry in India.*

## Indonesia



Passport valid for at least 6 months on your arrival back in home country.

E-Visa (B1- Tourist Visa on Arrival) **or**

E-Visa (C1 Tourist Single Entry Visitor Visa) **and**

Health Declaration Form **and**

Customs Declaration Form **and**

Bali Tourist Fee

## Kenya



Passport valid for at least 6 months on your arrival back in home country.

ETA- Electronic Travel Authorisation - Valid for 3 months from the date of issue for a maximum stay of 90 days.

## Laos



Passport valid for at least 6 months on your arrival back in home country.

Electronic Visa ( e-Visa) - Valid for 60 days from the date of issue for a maximum stay of 30 days.

## New Zealand

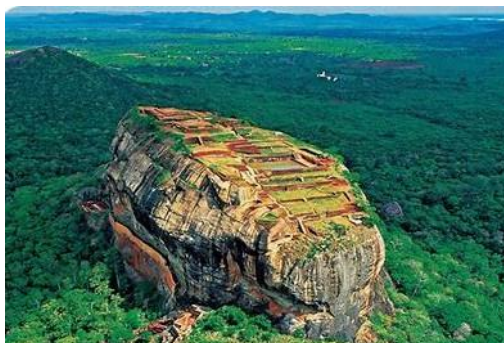


Passport valid for at least 6 months on your arrival back in home country.

ETA- Electronic Travel Authorisation- Valid for up to 2 years from the date of issue for a maximum stay of 3 months in a 12 month period **and**

New Zealand Traveller Declaration form completed 72 hours prior departure.

## Sri Lanka



Passport valid for at least 6 months on your arrival back in home country.

ETA- Electronic Travel Authorisation- Valid for 6 months from the date of issue for a maximum stay of 30 days.



## Tanzania



Passport valid for at least 6 months on your arrival back in home country.

E-visa- (Electronic Visa) obtained before departure valid for entry on the date specified on your application form, for a maximum stay of 90 days or Visa on Arrival **and**

Zanzibar Insurance purchased from Zanzibar Insurance Corporation (it is mandatory for all the travellers to ZNZ).

## United States of America



Passport valid for at least 6 months on your arrival back in home country.

ETA- Electronic Travel Authorisation- Valid for a maximum of 24 month or until your passport expires, whichever comes first. Max stay 90 days each entry.

## Vietnam



Passport valid for at least 6 months on your arrival back in home country.

Irish Passport Holders- E-visa (Electronic Visa) – single entry 30 days or multiple entry 90 days.

GB Passport Holders are visa exempted 45 days.
